

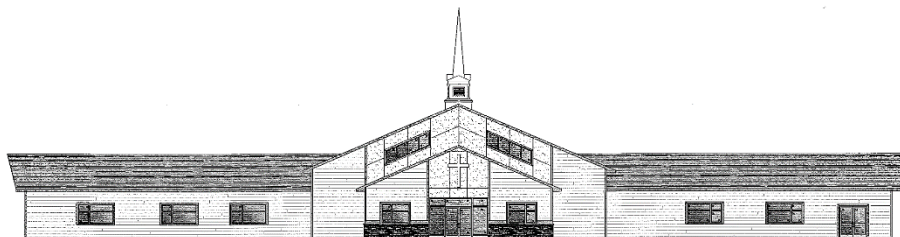

Property Developments

Congregations do lots of things. Most important is evangelism. “Make disciples of all the nations,” said Jesus. To make that happen a host of other activities need to happen. One thing is the upkeep of our property. Certainly this is only a means to an end, however. We dare not make the property we have become an idol. Instead, it is for practical reasons we are concerned.

As the Jewish people tended to their temple in Jerusalem and their local places of worship called synagogues, we do the same yet today. There are two big projects coming up that I’d like to share about. First, you will recall our church and parsonage roofs were heavily damaged by hail this last year. In addition, the siding of both structures took quite a beating as well.

Insurance has covered both needs. Indeed, we had no real choice in the matter as Bremer still holds the mortgage note for our properties. Our mortgage agreement requires any damage to be repaired as soon as reasonably possible. We were able to find a roofing contractor who was able to do the work of both structures before the snow came. To repair the chip damage to the siding will require both the church and parsonage to be painted this Spring. You will see the work beginning after Easter. Thankfully, our excellent insurance company, Church Mutual, has agreed to cover all expenses.

One other project is also in the works. At the March Council meeting, Dan Cain presented the idea to turn our unused land surrounding the church yard into a pollinator field. What is a pollinator field? This is an area of land created to support and benefit pollinators like bees, butterflies and other insects. Pollinators in turn play a vital role in the ecosystem by facilitating plant reproduction which also in turn support a rich life of birds and other herbivores. We thank Dan Cain who has been working on such conservation projects, for sharing the idea and donating his time preparing and planting the areas. All expenses will be covered by the local branch of Pheasants Forever. You should expect ground clearing in Spring and planting shortly thereafter. Once growth of meadow flowers begin you will also see birds, bees and lots of other little creatures to enjoy.

In the end, we reach in and out to make Christ known. But also know your Church Council also takes good care of the buildings to make that happen.



Present: Pastor Bryan Anderson, Aaron Buhr, Jackie Goodmanson, Neil Larson, Kevin Kamm, Bill McIntire, Anna Buhr, Laura Lieffring, Hannah Eckwall, Liane Petersen, and Dan Cain.

Meeting called to order by Neil Larson. Pastor led in prayer.

Reports: (Secretary, Budget, Pastor)- Aaron Buhr made motion to approve meeting minutes, Dan seconded, motion unanimously approved. Dan Cain made motion to approve Budget, and Pastor's Report, Hannah Eckwall seconded, motion unanimously approved.

Committee Reports

Worship- Easter services will be 8:00 AM & 10:00 AM, the youth will be having a brunch on Palm Sunday 9:00 AM-12:00 PM. Wednesday after Lent will be Family Activity Night "Kick Off" April 23rd. Details are in the works, but it will entail a dinner and then some activities. This is a pilot event that will hopefully continue through the summer. The last day of Confirmation is May 7th.

Education- Patti Wyss retires as Sunday School Superintendent. Received interest from Emily Larson to take team approach in leading. Will begin planning meetings after Lent.

Finance- Discussion about a 3-year capital gain campaign to reduce the mortgage. Possibly start this next fall.

Property- Bill McIntire said a new vacuum cleaner was purchased for the church. The Property committee has been changing the light bulbs in the church to LED.

Outreach- Blood Drive March 25th, 2025. Hope Alive June 3rd or June 5th. Date to be confirmed. Easter Egg Hunt April 12th. Dale looking for donations for bikes (\$72.00). Compassion Sunday was set for May 4th. but that date may have to be changed. Will know by the next Council meeting. Feed My Starving Children Food Packing Event will be scheduled on March 18th. Once we have a time and date confirmed we will get that information out to the congregation. Discussions with Emily Larson about CPR certification classes. Date to be determined. Head Start will be holding a Recruiting day for families beginning in May. Date to determined next week. They will make bird feeders and provide the food/snack. Jackie will be meeting with UW Extension on Thursday about a couple programs they would like to bring to our community.

Youth- Family roller skating date March 23rd, 2025. Cindy Nelson would like to have kayak trip on July 26th with a minimum of 25 people. Would like to get all settled by early April.

Old Business:

A. Dan Cain confirmed that Pheasants Forever will be paying for the seeding of a pollinator field. Dan also mentioned he would like to burn the field off (May-April), and spray with a weed killer and then plant in the fall. He would also like to include the youth and use this as an educational program too. Liane inquired if the field has to remain in a program. Dan explained there is no contract or program for this, and we are under no obligation to keep the field going, but stressed they would like to see it stay for a couple years at least.

New Business:

- A. Summer VBS- Council voted to keep Lacey Kamm as the leader for VBS and send letter to United Covenant Church.
- B. Pastor's vacation request was approved unanimously- Brian Wick will be the sub.
- C. A book study was mentioned and would probably start in the fall.
